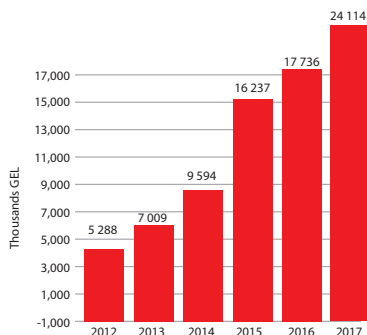


CASINO INDUSTRY OVERVIEW

Casino is one of the most profitable components of hotel business and the main driving force for attracting investments in the tourism industry. Currently, 12 casinos are operating in Ajara.

In 2017 more than 1 096 000 gamblers visited the casinos.

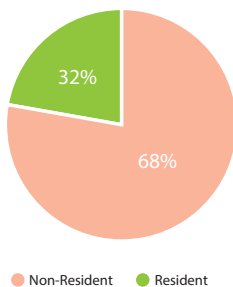
Contribution of Casinos to the Batumi Municipal Budget

ADVANTAGES OF

GAMBLING BUSINESS

- Supportive gambling business legislation
- Attractive investment climate
- Liberal visa policy
- Ban on gambling businesses in neighboring countries
- Proximity of Batumi (administrative center of Ajara) to the airport, sea port, railway and international border
- High level of security
- Developed transport infrastructure
- Less regulations and restrictions in the gambling industry
- Tax and permits preferences



ESTABLISHING A CASINO

Gambling and casino businesses are allowed by the Georgian Law.

On 25 March 2005 the Parliament of Georgia adopted Law on “Holding Lottery, Gambling and other Profitable Games”.

The Law stipulates state regulations for gambling business and legal protection clients’ interests and rights.

The license on gambling and other profitable games business is issued by the Ministry of Finance of Georgia www.mof.ge, which is also authorized to reject, make changes and amendments, extend or terminate issued licenses.

Gambling business is allowed only on the casino grounds and gaming machine areas. Casinos shall have at least 7 tables including the roulette one



STEP I

Registering a business entity is the compulsory procedure for starting a business and lasts one day.

STEP II

Issuance and revocation of permits, amendments and registry of gambling and profitable games are implemented by the Revenue Service of the Georgian Ministry of Finance.

Permit seekers shall submit a scanned version of the required documentation through the Revenue Service web page www.rs.ge

STEP III

An entrepreneur seeking a permit for establishing Casino/ Slot machine Club/Gambling Club must submit the following documentation:

- Extract from the Public Registry
- Confirmation of the permit fee payment

Documents for the Slot Machine Saloon application shall include the following:

Date and place of holding gambling games

Description and number of slot machines (name, type of modification, factory number, date of manufacture, country of origin), maximal and minimal number of bets and possible gains per machine

Slot Machine Saloon operating regulations, internal regulations, rules of gaming, and terms and conditions for claims.



CASINO

Description and number of gambling tables (name, factory number, date of manufacture, country of origin), maximal and minimal number of bets
Casino operating regulations; internal regulations, rules of gambling, and terms and conditions for claims
Samples of casino chips

GAMBLING CLUB

Description and number of gambling tables (name, factory number, date of manufacture, country of origin), amount of commissions, regulations for gambling club operating
Internal regulations, rules of gambling, samples of casino chips (if any)

ELECTRONIC GAMBLING

Actual address
A list and description of gambling activities, place and terms and gains received

For Internet Gambling: web address, terms of players' registration

Rules of handling deposit/balance

Full name of an operating company, legal address, telephone number, permit number, descriptions and regulations for gambling activities; information about gambling restrictions for persons under 18 shall be published on the web page in Georgian language

For telephone gambling: telephone number registered in Georgia

PERMITS VALIDITY PERIOD

Permit for opening Slot Machine Saloon / Casino / Bookmaker's / Lotto / Bingo is valid for 5 years

Permit for having promotional draw is valid for one year

Permit for opening a gambling club is valid for the duration of the permit issued for opening a casino or a slot machine saloon

The permits listed above shall not be issued if an applying entity has tax debts

Gambling and lottery business taxing and bookkeeping shall be regulated by the Georgian Law. Licenses for casinos and other profitable games shall be issued for the period of one year. **Owner of a hotel with at least 100 rooms is exempted from paying for casino (located on the hotel premises) license fee for 10 years from the date of the casino license acquisition (applicable only to Batumi, Kobuleti and Khelvachauri areas)**
Gambling business is exempted from VAT payment.

Fees for establishing gambling business shall be paid while receiving respective license and purchasing Fee Payment Mark. The mark indicates the right of the owner to open casino, bingo, lotto, bookmaking (betting) or any other type of gambling business. Purchasing, registering, fixing and changing damaged marks and also sealing dysfunctional premises shall be regulated by the Ministry of Finance of Georgia.
